  - iii. a termination fee (of the full engagement fee only) is payable by the Principal if no property is purchased and the agreement is terminated.
  - iv. The success fee in 3 ii is due and payable by the Principal on exchange of any of the contracts referred to in 3 ii (a) to (f)
  - v. The parties also expressly agree that the Agent shall be entitled to the success fee in 3 ii if the vendor of a Property or a Property is introduced to the Principal by the Agent at any time prior to the termination of this Agreement, and the Principal satisfies any of the requirements set out in 3 ii (a) to (f) within 3 months after such termination.

### Expenses

4. The Principal is liable for any building/pest inspections, strata searches and legal conveyancing. The Principal agrees to advance the funds for such or reimburse the costs to the Agent upon receipt of an invoice.

### Variation of Fees and Expenses

5. The services to be provided by the Agent and any fees or expenses payable by the Principal to the Agent pursuant to this agreement cannot be varied except as agreed by the Principal in writing.

### Financial Institution Taxes or Deductions

6. The Agent shall be entitled to be reimbursed for any taxes or deductions debited by banks or other financial institutions against the Agent's account during the term of the contract and attributable to the affairs of the Principal.

If the current rate is increased or decreased, the parties agree that any amounts referred to in this agreement will be varied accordingly.

The Principal will hold and keep indemnified the Agent against all actions, suits, proceedings, claims, demands, costs and expenses whatsoever which may be taken or made against the Agent, resulting from any statements or actions undertaken by the Principal, in the course of or arising out of the proper performance or exercise of any of the powers duties or authorities of the Agent under this agreement.
